No parking on vacant sites.

All trash must be put in trash bags. Sanitation company will not pick up/take garbage if it's not in trash/plastic bags.

Please use septic safe RV toilet paper if you feel the need to flush toilet paper. This can be purchased at Walmart in the automotive department in the RV section.

Please do not flush sanitary products into the septic system.

Littering is prohibited. Do not throw any left over food out on the ground such as chicken bones, etc. and/or cigarette butts.

Supervised campfires are permitted in the approved fire pit. Do not burn trash or dispose of oil, etc. Campfires are prohibited in hazardous conditions, such as drought and high winds. Put out the fire before retiring.

Inside dogs are permitted. No dogs are to be left outside unattended on dog runners or chains. Aggressive dogs are not allowed. Dogs must be vaccinated. Must show proof of vaccines upon request. **Please leash-walk your pet daily and clean up after your pet immediately by disposing of their waste in a poop bag and place it in the trash barrel.** Initial here _____

Overnight guests require pre-approval. A background screening will be conducted using a copy of the guests driver's license. An additional charge of \$50.00 per night per guest will apply. **Tenants do not have the authority to allow anyone to live with them.**
